- The Government of Nepal has allocated funds towards the cost of Kathmandu Valley Water Supply Improvement Project and intends to apply part of funds to cover eligible payments under the Contract for above said contracts. Bidding is open to all eligible Nepalese and Foreign Bidders.
- Project Implementation Directorate, Kathmandu Upatyaka Khanepani Limited ("the Employer") invites electronic bids from eligible bidders for below mentioned contracts through **International Competitive Bidding – Single Stage Two Envelope Bidding procedures**:
 - KUKL/BDS – 05: Laying of Transmission Main from Sundarijal to Chabahil Chowk, and Construction of Related Civil Structures

Eligible bidder should deposit a non-refundable fee of NRs 20,000.00 or US \$ 200.00 for each contract in the Project's bank Account mentioned below to purchase the Bidding Document of each contract on or before **30 July 2020; 12:00 hrs (NST)**

7. Site visit for the interested bidders shall be started at **11.00 AM** from PID office and pre-bid meeting shall be held at **2 PM (NST) on 10 July 2020 at PID Office** at Anamnagar, Kathmandu.
8. Electronic Bid must be submitted through PPMO's e-procurement (e-GP) system (www.bolpatra.gov.np/egp) on or before the deadline: **30 July 2020; 12:00 Hrs. (NST)**. Bids received after this deadline will be rejected.
9. The bids will be opened in the presence of Bidders' representatives who choose to attend at **30 July 2020; 13:00 Hrs. (NST)** at the office of **Project Implementation Directorate, Kathmandu Valley Water Supply Improvement Project, Anamnagar, Kathmandu**. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum of following amount, which shall be valid for 30 days beyond the validity period of the bid.

10. Bidders have the option to Bid for any one or more Contract Packages. Technical Evaluation for each package shall be carried out independently. Price bids of all technically qualified bidders shall be opened. If any bidder is found to be lowest evaluated for more than one Contract package, then its technical qualification is further evaluated whether it meets the cumulative requirements for more than one Contract package or not.
11. The contracts will be awarded to the Bidder or Bidders offering the lowest evaluated cost on the least cost basis to the Employer, subject to the selected Bidder(s) meeting the required qualification which shall be the sum (aggregated) of the minimum requirements for respective individual contracts as specified in the bidding document under section 3, items 2.3.2 : Average Annual Construction Turnover; 2.3.3 : Required Bid Capacity; 2.4.2 (a) : Contracts of Similar Size and Nature; 2.4.2 (b) : Construction Experience in Key Activities; 2.5 : Personnel and 2.6 : Equipment.
12. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
13. The KUKL/Project Implementation Directorate will not be responsible for any costs or expenses incurred by bidders in connection with the preparation and delivery of Bids.
