1. The Government of Nepal has allocated funds towards the cost of Kathmandu Valley Water Supply Improvement Project and Kathmandu Valley Wastewater Management project and intends to apply part of funds to cover eligible payments under the Contract for above said contracts. Bidding is open to all eligible Nepalese Bidders.
2. Project Implementation Directorate, Kathmandu Upatyaka Khanepani Limited ("the Employer") invites electronic bids from eligible bidders for the construction of Two Service Reservoir Tanks (SRTs) at Balaju under National Competitive Bidding – Single stage Two Envelope Bidding procedures:
Only experienced and eligible bidders with the following key qualifications-should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 286.13 million**
 - Minimum Work experience of similar size and nature: One Contract of **NRs. 286.13 million** with in last ten years
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents from PPMO's e-procurement system (www.bolpatra.gov.np/egp). Bidder shall download the Bidding Document for e-submission from PPMO's e-procurement (e-GP) system (www.bolpatra.gov.np/egp).
5. Bidders, submitting their bid electronically, should deposit a non-refundable fee of NRs 20,000.00 for purchasing of the bidding document for **Contract No.: KUKL/SRT/06B** on or before **10 February 2023; 12.00 hrs (NST)** in the Project's Rajaswa (revenue) account as specified below.

6. A pre-bid meeting shall be held at 2 PM (NST) on 27 January 2023 for Contract No.: KUKL/SRT/06B at PID Office at Anamnagar, Kathmandu. A site visit shall be organized by the Employer at 11 AM on 27 January 2023 before pre-bid meeting.
7. Electronic Bid must be submitted through PPMO's e-procurement (e-GP) system (www.bolpatra.gov.np/egp) on or before the deadline: **10 February 2023; 12:00 Hrs. (NST)**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend on **10 February 2023; 13:00 Hrs. (NST)** for Contract No.: KUKL/SRT/06A at the office of **Project Implementation Directorate, KUKL, Anamnagar, Kathmandu**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum NRs 13.50 million, which shall be valid for **30 days** beyond the validity period of the bid.
9. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. The KUKL/Project Implementation Directorate will not be responsible for any costs or expenses incurred by the bidders in connection with the preparation or delivery of Bids.
