

**Invitation for Bids**

1. The Government of Nepal has received a loan from Asian Development Bank (ADB) towards the cost of Kathmandu Valley Wastewater Management Project. Part of this financing will be used for payments under the Contract named above. Bidding is open only to bidders from eligible source countries of the ADB as described in Section 5 of the Bidding Document.

2. The Project Implementation Directorate, Kathmandu Upatyaka Khanepani Limited ("the Employer") invites sealed bids from eligible bidders, based on post-qualification criteria, for the construction and completion of the Works as described below.

The works mainly comprise of Design Build wastewater treatment plants at two locations, Gokarna (3 MLD capacity), and Hanumanghat (1 MLD capacity) using MBBR technology with five years Operation & Maintenance. International Competitive Bidding will be conducted in accordance with ADB's Single Stage-Two Envelope Bidding procedure.

3. The capital expenditure of above stated work will be financed under ADB Loan and Government of Nepal/KVWSMB for Design and Build phase and Operation & Maintenance expenditure will be financed by Government of Nepal/KVWSMB.

4. Bidding is open to eligible bidders who fulfill qualification requirements given in Section 3 of the bidding document, partly stated below;

- Minimum average annual turnover of **USD 9 million** calculated as total certified payments received for contracts in progress or completed within the **last five years**.
- Participation in at least one contract under Design Built Operate (DBO) or Built Operate and Transfer (BOT) of wastewater treatment plant (WWTP) or decentralized wastewater treatment plant (DEWATS) of 3.0 MLD or more capacity that has been successfully or substantially completed within the **last Ten (10) years**.
