1. The Government of Nepal (GON) has received a loan from Asian development Bank (ADB) towards the cost of **Kathmandu Valley Wastewater Management Project (Loan 3000)**. The proposed Kathmandu Valley Wastewater Management Project (Project) will support the ongoing efforts of the Government of Nepal (the government) towards improving the wastewater service in Kathmandu Valley. The Project will invest in development of Neighborhood Sewer network improvement, Expansion of Interceptor Sewers and Waste water Treatment Plants. The resultant synergy of the proposed project is expected to lead to increased efficiencies, greater improvement in service delivery and higher impact on health & hygiene outcomes; and quality of life of people living in Kathmandu Valley. The Government of Nepal and Asian Development Bank have agreed to utilize a part of the loan proceeds for the project related activities. Further a part of the proposed loan proceeds will be used to finance national individual consultants for the overall management and technical support for implementation of urban water and wastewater sector projects by Project Implementation Directorate.
2. The Project Director on behalf of Project Implementation Directorate (PID) invites Expression of Interest from eligible National Individual Consultants for management and technical support of PID for the following position having appropriate management technical and geographical competence;

The Project Implementation Directorate (PID) of Kathmandu Upatyaka Khanepani Limited (KUKL) plans to engage the above position to take care of all aspects of the project, including assisting the Project Director (PD) in overall project management support for design, procurement, monitoring and evaluation of project implementation activities. The Experts will report and work under the overall guidance of the PID and is expected to commence the services by 1 February 2021.
