The Government of Nepal has received financing from the Asian Development Bank (ADB) toward the cost of Kathmandu Valley Wastewater Management Project, and it intends to apply part of the proceeds of this financing to payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The Project Implementation Directorate, KUKL ("the Purchaser") invites sealed bids from eligible Bidders for Supply of **Wastewater Surveillance Lab Equipment**.
3. National Competitive Bidding will be conducted in accordance with ADB's "Single-Stage, Single Envelop" procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:
  - Successful completion as main supplier within the last 3(three) years, of at least 2(two) contracts each valued at **NPR 5.63 million** with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply).
  - Minimum average annual turnover of **NPR 14.08 million** calculated as total payments received by the Bidder for contracts completed or under execution over the last **3(three)** years.
