1. The Government of Nepal (GON) has received a loan from Asian development Bank (ADB) towards the cost of **Kathmandu Valley Water Supply Improvement Project (Loan 3255)**. The proposed Kathmandu Valley water Supply Improvement Project (Project) will support the ongoing efforts of the Government of Nepal (the government) towards improving the water Supply service in Kathmandu Valley. The Project will improve access, efficiency and reliability of water supply services to the residents of Kathmandu valley. The resultant synergy of the proposed project is expected to lead to increased efficiencies, greater improvement in service delivery and higher impact on health & hygiene outcomes and quality of life of people living in Kathmandu Valley. The Government of Nepal and Asian Development Bank have agreed to utilize a part of the loan proceeds for the project related activities. Further a part of the proposed loan proceeds will be used to finance national individual consultants for the overall management and technical support for implementation of urban water and wastewater sector projects by Project Implementation Directorate.
2. Project Implementation Directorate (PID) invites Expression of Interest from eligible National Individual Consultants for management and technical support of PID for the following position having appropriate management technical and geographical competence;

The Experts will report and work under the overall guidance of the PID and is expected to commence the services by **1 March 2023**.
